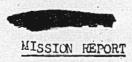

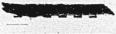
- 1. 61st Troop Carrier Group.
- 2. 15th Troop Carrier Squadron.
- 3. Neptune Freeport 13 C-47A and 1 C-47 Resupply Equipment. (Serial #38)
- 4. Take off: 0330 o'clock, 7 June 1944. Returned: 0825-1040 o'clock, 7 June 1944.
- Nine aircraft followed prescribed route.
 Four aircraft deviated due to weather.
- 6. 7/10 10/10 clouds from 200/? feet.
- 7. None.
- 8. Fired at from ground, red tracers observed weak to moderate accurate fire was moderate North and South of DZ.
- 9. None.
- 10. American troops and tanks seen at DZ.
- 11. None.
- 12. Time over DZ 1st plane: 0603 o'clock.

Last plane: 0800 o'clock. F/O Charles O. Irvine.

Altitude: 500 ft. Air speed: 120 mph.

- 13. Three aborts due to weather. lst Lt. Baily (nmi) Smith a/c #322 lst Lt. Gaylord M. Ten Eyck a/c #875 lst Lt. Dwight L. Faulkner a/c #693
- 14. Communications successful except there were no visual panel T's on DZ.
 Aircraft #309, piloted by F/O Charles O. Irvine, reports the following:
 Heard May Day on C. Channel stating ship had already struck water.
 Got coordinates and reported them. Circled two life rafts between
 Paducah and Spokane. Gave fix on them. One raft had two men in it,
 and the other had one man in it.
 Aids at Gallup and Spokane missing.
- 15. One Radio Operator injured his back when hw was thrown against the wall due to evasive action taken by aircraft.
- 16. Aircraft #897, piloted by 1st Lt. Claude E. Breeden, was reported seen down on the water between Spokane and Paducah and was successfully ditching.

16. a/c #183 - ten bullet holes in fuselage - Flyable.

a/c #208 - several bullet holes in fuselage - Flyable.

a/c #930 - bullet hole in gas tank and both ailerons out - Non-flyable.

a/c #776 - bullet holes in tail, wing, and fuselage - Flyable.

a/c #934 - bullet holes in nacelle of left engine - Flyable.

a/c #637 - bullet holes in fuselage - Flyable.

a/c #933 - bullet holes in fuselage - Flyable.

a/c #332 - bullet holes in nacelles and rudder - two pararacks damaged by bundles - Flyable.

- 17. Weather caused four a/c to deviate from prescribed route.
- 18. Yes except weather and the DZ was estimated to have been approximately 22miles NE of DZ as briefed.
- 19. One a/c dropped 1 mi NE of DZ.
 One a/c dropped 1 mi S of DZ.
 Others dropped on DZ.
- 20. Balloons observed around Paducah flying at approximately 200 ft. Smashed gliders observed SE of DZ. Flame or rocket was observed SE of DZ. Fighter cover good.
